# Sign Now to Prevent Genpatsu-Shinsai!

A massive earthquake (Great Tokai Earthquake), greater than magnitude 8 according to the Japanese government report which numerous scholars have been warning is about to occur directly below the Hamaoka nuclear power plants (Chubu Electric Power Co.). In Hamaoka, there are four reactors under operation and one is under test operation.

In spite that nuclear power plants are predicted to hit by the massive earthquake for the first time in history, the government and municipal office and electric company have merely repeating, "They are absolutely safe." There are mounting anxieties among the residents in the area. Once Genpatsu-Shinsai occurs, it will be almost impossible to rescue the victims, and numerous number of lives that had been supposed to be saved cannot be saved.

Not only that, environmental contamination caused by radiation can spread even outside of Japan, threatening foods and lives, and horrendous effects could last among children and their offsprings. We can never know how much impact will be caused economically and socially.

Though we cannot stop the occurrence of an earthquake, we can stop the nuclear power plants. We should not believe in technology too much and we should be humble in front of the natural disaster. Let us request the halt of Hamaoka nuclear power plants to those who are in charge of people's lives and safety. Please cooperate our petition campaign.
